For and in consideration of being permitted to register and/or participate in programs conducted and/or sponsored by FHE or at Floyd Hall Arena, Little Falls, New Jersey, ("Arena") releasor, for him/herself, parent(s) or legal guardian(s), spouse, legal representatives, heirs, and assigns, hereby releases, waives, and discharges FHE, its officers, owners, and employees, referred to as Releasees, from all liability to the Releasor, his/her parent(s), spouse, legal guardian(s), legal representatives, heirs, and assigns for any and all loss or damage, and any claim or damages or cause of action resulting therefrom, on account of injury to the Releasor's person or property, even injury resulting in death of the Releasor, whether caused by negligence of Releasees or otherwise while the Releasor is competing, working, or for any purpose participating in programs sponsored or conducted by the Releasee or held at Releasee's ice rink facility. I also understand that the participant is responsible for furnishing his/her own equipment and is responsible for its safety and good operating condition regardless of where it was obtained. Releasor agrees to indemnify the Releasee and each of them from any loss, liability, damage, or cost they may incur due to the presence of Releasor in or upon the ice or property at the Arena, whether caused by the negligence of the releasees or otherwise. Releasor hereby assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence of Releasee or otherwise while in or upon the ice and while competing, officiating in, working or for any purpose participating in ice hockey or skating. Releasor expressly agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of New Jersey, and that if any portion thereof is held invalid, it is as agreed that the balance shall notwithstanding continue in full and legal force and effect. Releasor further states that he/she is of lawful age and legally competent to sign this affirmation and release; that he/she understands the terms herein are contractual and not mere recital; and that he/she has signed this document of his/her own free act. Releasor has fully informed himself/herself of the contents of this affirmation and releases by reading it before signing it. Releasor has responsibility of physical fitness and capability to perform under the normal conditions of an ice hockey or skating program, and is physically fit as attested to by medical examinations. Releasor understand that ice hockey and skating are dangerous sports that can result in permanent disability, injury or death. Releasor understands that he/she is waiving substantial rights by signing it. In witness whereof, releasor has executed this Release.
